Guidelines for oral presentation, clinical case presentation, oral health promotion videos and Pecha-Kucha presentation as given below:

A. Oral Presentation (Original Research) guidelines:

1. Mode of Presentation: PowerPoint Presentation (Online Synchronous)
2. Size of slides: 16x9 size.
3. Timing of presentation: 8 minutes for presentation and two 2 minutes for the Q&A.
4. Those participants who cannot present using an online platform due to any reason such as limitation of internet connection then they need to send the pre-recorded PowerPoint presentation in MP4 file. Recorded video will be screened during allotted time and authors must be present online. After screening of the recorded video, Q&A session will be conducted online through ZOOM. The ZOOM link will be provided to all registered authors only.
5. Presenter must disclose any personal or co-author potential conflict of interest and agree to IMU Policy on Full Disclosure on the first slide.
6. General outline of the Presentation
 - Title slide: Acknowledge your university or practice by including the logo
 - Background/Introduction
 - Hypothesis
 - Aim and Objectives
 - Materials and Methods
 - Results
 - Conclusion
 - Acknowledgement
 - Source(s) of funding
 - Author contact information
7. Rules for Submission
 - All submitted research findings must be carried out by students.
 - Projects being submitted must be the original research.
 - Previously published abstracts (in print or any electronic format) or those presented at another meeting are not allowed.
 - Mention name of the presenting author and co-authors on the title slide.
 - Presenting author must be either principal investigator or co-investigator.
 - Not more than one oral presentation is allowed as a presenting author.
 - Individuals can co-author multiple abstracts.
 - Authors need to affirm that any work with human or animal subjects reported in the abstract complies with the guiding principles for experimental procedures found in the Declaration of Helsinki of the World Medical Association, and this research project has been duly cleared by my Institutional Review Board (IRB) or Institutional Ethics Committee or an equivalent ethical body.

B. Case Presentation (Case report OR Case series) guidelines:

1. Mode of Presentation: PowerPoint Presentation (Online Synchronous)
2. Size of slides: 16x9 size.
3. Timing of presentation: 8 minutes for presentation and two 2 minutes for the Q&A.
4. Those participants who cannot present using an online platform due to any reason such as limitation of internet connection then they need to send the pre-recorded PowerPoint presentation in MP4 file. Recorded video will be screened during allotted time and authors must be present online. After screening of the recorded video, Q&A session will be conducted online through ZOOM. The ZOOM link will be provided to all registered authors only.
5. Presenter must disclose any personal or co-author potential conflict of interest and agree to IMU Policy on Full Disclosure on the first slide
6. Rules for Submission
 - All submitted cases must be within the parameters of undergraduate and post graduate training.
 - Presentation must include patient case/s with photographs, radiographs and text.

- The materials used in the patient treatment must be mentioned whenever necessary.
- Every submitted case/s must have a patient consent form attached.
- The case/s must be treated by the student.
- Not more than one case report or case series per student is allowed as a presenting author.

C. Oral health promotion video guidelines:

1. Mode of Presentation: MP4 file.
2. Recorded video will be screened during allotted time and authors must be present online. After screening of the recorded video, Q&A session will be conducted online through ZOOM. The ZOOM link will be provided to all registered authors only.
3. Each entry must focus on oral health promotion.
4. Students may work together in groups or submit entries as individuals.
5. The length of the video should not exceed 120 seconds (two minutes), not including the 5 seconds title screen.
6. All entries should begin with a 5-second full-screen “title screen” that includes the following information:
 - Title of video
 - Lead Producer’s name
 - Total running time (not including the 5 seconds title screen)
7. All information presented in the video must be cited, giving credit to the original source. Plagiarism of any kind will result in disqualification from the competition.
8. No copyrighted materials (music, images, etc.) may be used for this contest unless you own the copyright or have a license to use the material for this contest.
9. No professional assistance is allowed.
10. Students should keep at least one copy of their video. Conference authority is not responsible for any films that are lost, damaged, or that do not upload properly.

D. Pecha-kucha (Tell us How) competition guidelines:

1. Mode of Presentation: PowerPoint Presentation (Online Synchronous).
2. Theme: Overcoming challenges with MCO in dentistry.
3. This is to showcase the challenges faced during MCO and how you managed to overcome them. It can include dental research, teaching and learning or patient management.
4. Timing of presentation: 3 minutes for presentation and 2 minutes for Q&A. Those participants who cannot present using an online platform due to any reason such as limitation of internet connection then they need to send the pre-recorded PowerPoint presentation in MP4 file. Recorded video will be screened during allotted time and authors must be present online. After screening of the recorded video, Q&A session will be conducted online through ZOOM. The ZOOM link will be provided to all registered authors only.
5. Maximum number of slides: 10 slides.
6. Presentation with pictures showing ways to overcome each challenge are encouraged.
7. You can use visuals/ photos / caricature on your slides.
8. Each registration can have one participant presenting one challenge.
9. Participants can register multiple time to present different challenges.

Three awards will be given in each category:

- 1st place: RM 500
- 2nd place: RM 300
- 3rd place: RM 200

**e-Certificate of the presentation will be awarded to the presenting author only and e-certificate of the attendance will be awarded to the registered participants.*
